March 9, 2020

Wall-Badlands Area Chamber of Commerce Board President Dustin Curr called the meeting to order. Chamber Member Jody Bielmaier led the Pledge of Allegiance. Susie Kjerstad moved to approve meeting minutes from the February Chamber Luncheon. Second made by Anne Jo Spotted Bear. Motion carried. Those in attendance reviewed the February Treasurer's Report. Susie Kjerstad moved to approve the February Treasurer's Report. Second made by Rick Hustead. Dustin announced upcoming events in the Wall community.

Wall-Badlands Area Chamber of Commerce: Kelsey Clark: The 2020 Wall-Badlands Area Chamber of Commerce Annual Meeting & Banquet will be held on Thursday, April 16. The Annual Meeting will begin with social hour at 5 PM in the Wall Community Center Grand Hall. At 6 PM dinner will be served. The program for the Annual Meeting will begin at 6:30 PM and the guest speaker for the evening will be Nathan Sanderson, Executive Director of the South Dakota Retailers Association (THE ANNUAL MEETING HAS BEEN POSTPONED DUE TO RECOMMENDATIONS FROM THE CDC). The March Farmer's Market and Produce Exchange will be March 11 in the Wall Mall; the next Farmer's Market will be April 8. The Wall City-Wide Yard Sale will be held May 30. The Chamber office has been experiencing problems sending emails to some Chamber Members; Kelsey is working on finding a solution, in the meantime, information has been posted on the Chamber Facebook page.

Wall Ambulance Dist.: Carrie Schell: To keep from spreading germs such as the Coronavirus be sure to wash your hands, for at least 20 seconds, and sanitize surfaces frequently. It is being discussed how information will be distributed if there is a positive case in the community.

City of Wall: Marty Huether: Monthly sales tax for February was awesome and BBB taxable sales are up also; Marty is hoping to keep up the momentum through the year. There are 3 councilmen whose terms expire this year; 1 from each ward. Mike Anderson of Ward 1 is re-running unopposed. There will be an election in Ward 3 between incumbent candidate Dan Hauk and candidate Bruce Dunker. No petitions were turned in from Ward 2, therefore, the council will select an individual to fill the seat for 1 year. Weekly meetings will be held in order to be prepared if the Coronavirus affects the Wall community. Marty is working with the county as well as Monument Health to have a plan in place if there is an outbreak. Anyone who is going to protest property tax assessments must have the paperwork turned into the City Office by March 13.

Wall Economic Development: Liliya Stone: WEDC has been working with the Wall City Council to create ordinances and complete paperwork regarding the Industrial Park. Three Governors Houses will be moved onto the lot at 402 Glenn St. There have been a lot of question about the houses, therefore an informational class will be conducted with assistance from Cheyenne McGriff. A Housing Committee Meeting will be held March 9; anyone interested in being part of the committee is invited to attend.

Badlands National Park: Mike Pflaum: The park will be posting resources from the Center of Disease Control to help prevent to spread of Coronavirus and will be placing hand sanitizer at all entrances and gathering areas. At this time there are no restrictions or closures to any national parks across the nation because of the Coronavirus. Operation hours at the park will be extending for the spring season soon. The Astronomy Festival will be held in Badlands National Park on August 14-16; the event has gathered good attendance and people are planning trips to attend this year. February visitation is looking good and the report will be published soon.

Minuteman Missile NHS: Eric Leonard: Construction at the visitor center is mostly complete. The site will be moving from winter hours to 7-days of operation by the end of the month. February visitation and Year-to-Date visitation are both up.

Rodeo Booster Club: Mary Williams: Wynn Schaack has qualified to participate in the American Rodeo. Upcoming rodeos in Wall will be: Pennington Co. 4-H Rodeo, May 30; SDHS Rodeo, June 5-7; PRCA (Celebration) Rodeo, July 10 & 11. The Celebration Rodeo will be a PRCA Rodeo with professional Continued on Page 3

rodeo acts, entertainment and announcers. Travelers continue to use the rodeo grounds to board their horses while traveling. Thank you to the Chamber and the community for supporting the Rodeo Booster Club. Rodeo contestants who perform in the Wall Rodeo Arena continue to complement how good the Wall Rodeo Area is.

Badlands Quilters: Judy Yocum: The Quilt Weekend Getaway will be held March 13 & 14 in the Wall Community Center. There are about 60 people from across the state who will be attending the event and staying in our community for the weekend. Quilting classes will be Saturday with a banquet Saturday evening at the Methodist Church. The Badlands Quilters try to keep their business local when planning the Weekend Getaway. Everyone is welcome to attend the Bed-Turning activity Friday night where attendees can display their quilts. Money earned at the Weekend Getaway is used to make Solider Quilts which are then donated to the hospice unit at Fort Meade or given at the Veterans Day Program held at the Wall School.

Golden West: Jody Bielmaier: Community meetings for Fiber to the Home, are completed and the project will begin in communities soon. The Golden West Scholarship applications can be picked up at the school or found online; deadline to apply is March 16. Golden West is offering customers a free trial of higher speed internet; call the office for more information.

West River Electric: Dawn Hilgenkamp: WREA is looking for individuals to become members of the Member Communication Committee; call the office for committee applications. In March a total of \$750,000 will be given in bill credits; credits will be applied to March bills. WREA will sponsor area students to attend the South Dakota Rural Electric Youth Excursion, July 27-31. The event will be held in North Dakota and allow students the opportunity to tour power plants and a coal mine. Freshmen, Sophomores and Juniors, whose parents are members of WREA, are eligible to attend. The deadline to apply is May 22. Wild Spring Solar, located south of New Underwood, will provide energy to WREA. There will be no rate increases because of the project, however the project could potentially create additional tax revenue for the area.

Sander Sanitation: Brianna Myers: Brianna is a Sales Specialist for the locally owned company which services the Black Hills communities. Recently, Sander Sanitation expanded services to Wall, New Underwood and Wasta in conjunction with receiving the Badlands National Park contract. Sander Sanitation offers both residential and commercial services. Please contact Brianna with any questions.

2020 City Council Candidates: The three individuals who are re-running/running for City Council were invited to attend the luncheon to network with Chamber Members; Bruce Dunker was present.

With no other businesses, Susie Kjerstad moved to adjourn the meeting. Second made by Jody Bielmaier. Motion carried.



The Wall City Council approved a resolution, on March 23, that would close certain types of business within the City of Wall to on-site/on-sale patrons. The Resolution also states that all businesses continuing to operate should implement procedures to ensure social distancing and operate in compliance with federal and state health guidance in order to prevent the spread of COVID-19.

With much concern regarding COVID-19 (Coronavirus), the Wall-Badlands Area Chamber Board of Directors has postponed the 2020 Annual Meeting & Banquet (scheduled for April 16) until further notice. This is not a decision that was made lightly and we apologize for any inconvenience or confusion. The Chamber Board will continue to follow this situation and potentially hold an Annual Meeting & Banquet later in the year. There will be no April Luncheon.



CARES Act: Brief Overview

The CARES Act (Coronavirus Aid, Relief and Economic Security) is a roughly \$2 trillion coronavirus response bill for individuals, small businesses, larger businesses, state and local governments, healthcare facilities, education and more.

INDIVIDUALS: Most individuals earning less than \$75,000 annually can expect a one-time payment of \$1,200. Married couples who file taxes jointly and make less than \$150,000 annual can expect \$2,400 and \$500 per child. The act also allows people who receive Social Security to be eligible for a payment.

UNEMPLOYMENT: Those who are currently unemployed due to COVID-19 are now eligible for \$600 more per week on top of the unemployment amount they receive from the state. That boosted payment will last four months. The legislation also adds 13 weeks of unemployment insurance. Gig workers and self-employed individuals can also receive benefits.

TAXES: The deadline for filing 2019 taxes has been extended to July 15.

SMALL BUSINESSES: Companies with 500 or less will have access to emergency grants and loans. The act provides \$10 billion for grants of as much as \$10,000 for immediate operating costs. The Small Business Administration will also be able to allocate \$350 billion in loans, up to \$10 million per business. The government might forgive portions of the loan used for payroll expenses, utilities, rent, or mortgage insurance. Small businesses with existing SBA loans have access to \$17 billion to cover six months of payments automatically.

LARGE BUSINESSES: Roughly \$500 billion in loans and other money has been set aside for big corporations. A special committee and inspector general would provide oversight of all loans, uses of tax payer dollars and pandemic recovery.

ALL BUSINESSES: The bill establishes a fully refundable tax credit for businesses of all sizes that are closed or distressed to help them keep workers on the payroll. The goal is to get those employees hired back or put on paid furlough to make sure they have jobs to return to.

PUBLIC HEALTH: \$100 billion has been budgeted to hospitals battling the coronavirus.

The bill allows \$1.32 billion in additional funding to community health centers. The stimulus package also reauthorizes a telehealth program so doctors can continue virtual appointments. Veteran's health care is budgeted \$20 billion and Indian Health Services is set to receive \$1 billion.

AGRICULTURE: The act includes \$9.5 billion in emergency aid for farmers and ranchers and replenishes the Commodity Credit Corporation with \$14 billion.

FOOD PROGRAMS: To provide more meals for students, \$8.8 billion has been set to give to schools. \$15.5 billion will go to the SNAP (Supplemental Nutrition Assistance Program) to help cover the cost of new applicants. Food banks and community food distribution programs are set to receive \$450 million.

STATE & LOCAL GOVERNMENTS: The \$339.8 billion for state and local is divided up between COVID-19 response efforts as well as grants, schools and higher ed, and children and families.

EDUCATION: The bill includes \$43.7 billion in relief for higher education students and graduates with outstanding federally owned student loans. There are also other area of education that will be receiving funding.
